

<u>If</u> the Applicant is not the owner then evidence that the owner is aware of and consents to the filing of this application must be provided in the form of a **Notarized Agent Letter** before the application will be accepted to proceed. The Planning Department can provide a standardized letter form that must be signed by each party and notarized. Agent letter forms are provided via email or picked up at the Planning Office.

A Sketch Map or Site Plan is required for every application. Whether it be hand drawn, sketched on the computer, or uses our Online GIS Map, you will need to upload a document to help us visualize your proposed project and get accurate addresses assigned, if needed.
