- ➤ McPhee Reservoir active capacity toped at 105,949 acre/ft. on 5/30/22. On 05/12/23 the capacity was at 208,111 acre/ft. Downstream releases were raised from 3400cfs to 4000cfs on 5/12/23.
- ➤ Groundhog capacity on 5/12/23 was 13,111 acre/ft.
- ➤ Jackson Gulch Reservoir capacity on 5/4/23 was 8600 scre/ft. @ 86%. Inflow is at 89cfs and bypassing 220cfs to the Mancos river. Reservoir release is at approximately 45cfs. Inflow won't change until the reservoir is full. Mancos snotel is at 933% and the basin at 307%
- Various plans are implemented concerning our water run off issues in the County.

# State Emergency Operations Center (SEOC) Status Level 3

The SEOC is at Level 3. SEOC continues to support of the following: Migrant sheltering support in Denver, Marshall Fire recovery, HPAI. Staff are monitoring flooding on western slope. SEOC is operational Monday through Friday from 8 a.m. to 5 p.m.

Highly Pathogenic Avian Influenza (HPAI): SEOC Activation. The Colorado Department of Agriculture (CDA) and USDA are coordinating the state response to HPAI cases in the state. Use the CDA website and map for resources and information updates. A situation report will be posted on the CDA HPAI webpage each Friday.



#### EMERGENCY MANAGEMENT ADMINISTRATIVE REPORT

## **Emergency Management Performance Grant (EMPG):**

- We received \$46,793.70 for 2022.
- 2023 grant 1st Qtr. was submitted, waiting for approval and payment.

## Hazard Mitigation Grant Program (HMGP):

- Town of Dolores generator and siren project is approved by FEMA. The Town is moving forward with their equipment purchases. Contract is complete with FEMA and they are working on the RFP, and developing an IGA with the Dolores Fire Protection District.
- Town of Mancos, Mancos Rural Water and Mesa Verde NP are collaborating on a Source Water Protection Plan. Federal approval was received, and a grant award of \$5,000 was issued to Mancos Rural Water. This is a development and implementation grant for source water protection planning given by Colorado Water Quality Control Division. They are implementing this project.
- County generators grant project was submitted and approved by the State for the 4 remaining generators requested for County buildings. Coroners Building, Annex 1, Annex 3, and the Fairgrounds. Grant will pay 90% of the cost. Grant request \$170,486.40 was submitted on 1/28/22 and is still under Federal review. County 10% capital cost is \$17,048.64 for three-year project.

# **Local Emergency Planning Committee (From LEPC Chair):**

- The grant purchased Propane Emergency Response Kit was received in early May and is being housed at the Dolores Fire Protection District. In late 2022, the Dolores Fire Protection District held training on the hazards of Propane and learned how to utilize the Response Kit. We are hoping more training will be available in the near future for all of the Montezuma County First Responders to be able to utilize the Kit to its full potential!
- Radiological equipment / survey meter quotes have been received and a meter has been decided upon. There is enough funding to purchase three meters which will be dispersed in the Four Corners area. Montezuma County is on the list to received one of the meters, once received.

• Tier II / Extremely Hazardous Substance (EHS) tours are underway in Montezuma County. We have eight facilities which need to be toured, two of which are not accessible at this time due to snow. One facility has been completed and two were attempted, but tour guides were called away at the last moment, so the tours is being rescheduled. Once the EHS facility tours are completed, there will be a "Haz/Risk Assessment" generated which will be included in the Montezuma County Emergency Response Plan for chemical emergencies. This plan is part of the Emergency Planning and Community Right-to-Know Act (EPCRA), Section 324.

## Memo of Understanding (MOU):

- EM signed the MOU with RE-1 School district to be part of the District's Safety Team. No funding required. MOU is in progress.
- MOU for County and Municipalities is under review by all attorneys. Unknown when the final draft will be circulated.

## Southwest All Hazards Advisory Council (SWAHAC):

• Region is compiling an Integrated Preparedness Plan (IPP).

# Training and Exercise Plan (TEP) and Intergraded Preparedness Plan (IPP):

 New 3-year plans for 2024-2026 for the County has been developed and will be submitted to the state by 6/15/23.

## Training/Drills:

- The E/L/K0105 Public Information Basics training is set to begin May 23-25, in the County EOC. 24 students are registered.
- The AWR-O302 All Hazards Pipeline Security for Rural Communities training was held on 5/6/23 at the Dolores Fire Protection District Station #1. 17 Students attended this class.
