## 2023- Montezuma County Weed Program Low Income Cost-Share Application

This cost share is designed to assist lower income county residents manage noxious weeds on their property. If approved Montezuma County Noxious Weed Department will help coordinate a treatment of noxious weeds and will pay 100% of the bill up to a determined maximum depending on cost share funds available.

### **Income Limitations**

You can apply for the cost share only if your income is below a certain level. This level is based upon your adjusted gross income (AGI) or your non-taxable benefits, like Social Security and pension payments.

- **Single, head of household or a qualifying widow** - AGI is \$24,000 or lower.
- **Married filing jointly and you and your spouse satisfy the other requirements** - AGI is \$50,000 or lower.
- **Married filing separately** - your AGI is \$24,000 or lower.

Applications will be reviewed by the Weed Supervisor and the Noxious Weed Advisory Board of Montezuma County.

***Application review and fund disbursement is on a first come, first served basis.***

Common tansy, Cutleaf teasel, Spotted knapweed, Diffuse knapweed, Russian knapweed, Yellow toadflax, Dalmatian toadflax, Yellow Starthistle, Myrtle spurge, Leafy spurge, Mediterranean sage, Scentless chamomile, Mayweed chamomile, Musk thistle, Canada thistle, Scotch thistle, Bull thistle, Plumless thistle, Russian thistle, Eurasian watermilfoil, Houndstongue, Hoary cress, Oxeye daisy, Perennial pepperweed, Russian olive, Salt cedar, Sulfur cinquefoil, Halogeton, Chicory, Common burdock, Common mullein, Downy brome, Field bindweed, Poison hemlock, Puncturevine, and Redstem filaree.

***Leafy Spurge** infestations will be managed by the County Weed Program at no cost to the landowner.*
