
Montezuma County Outdoor Recreation Demand-Side Assessment

Introduction

A compilation of data about outdoor recreation from state agencies was presented to the community as the project kicked off during spring of 2023. This includes locally applicable highlights from "Colorado Travel Year" by Colorado Tourism Office which highlights statewide outdoor recreation visitation, trip characteristics and visitor demographics. Colorado Tourism Office also issues annual "Economic Impacts of Travel" reports which estimate total travel spending and economic impacts for the state, by region and by county. Nationwide and statewide outdoor recreation participation rates were also presented in the early stages of the project.

Montezuma County Direct Basic Jobs, Total = 9,410




Included tourism direct basic jobs (DOLA):

- <u>Resort</u>: resorts, attractions, national parks, accommodations
- <u>Second homes</u>: construction, property management
- <u>Services</u>: eating and drinking, retail shopping, entertainment

- According to DOLA, tourism is 16% of direct basic jobs or 1,490 jobs
- Households bring in retirement, public assistance and investment income and commuter wages
- "All else" includes finance, insurance, real estate, professional services, trade, transportation, communications, construction, mining, manufacturing, and government.


Overnight Leisure Trips in Colorado, 2021

Source/Origin of Outdoor Overnight Visitors, 2021




Top Five State Sources of Overnight Outdoor Visitors

Overnight Outdoor Trips: Activity Participation Rates, 2021


Top Activities and Experiences for Outdoor Trips -Participation Rates

Accommodations for Overnight Outdoor Visits



- Average travel party size, composition: 3.2 people total, 2 adults, 1.2 children


Overnight Outdoor Trips: Shopping, 2021

- These are retail categories that are suited for main streets/downtowns


Overnight Outdoor Trips: Dining, 2021

Day Trips in Colorado, 2021


2021 Marketable Day Trips

Spending: Overnight Vs. Day Trips


Spending Per Person Per Trip, 2021


Colorado Travel Trends

Travel Spending in Montezuma County 2012-2021






- Travel spending in Montezuma County grew by 34% in 10 years
- Travel spending quickly recovered from COVID slump


Montezuma County Visitor Spending by Category, 2021

Origin of Visitors to Montezuma County




Visitors to Montezuma County, 2019-2022

U.S. Outdoor Recreation Participants: Hiking/Running




U.S. Annual Participants (Thousands)

U.S. Outdoor Recreation Participants: Trail Sports





Thousands of U.S. Annual Participants: Camping, Hunting and Fishing



- Camping exhibited a Covid-related increase


U.S. Outdoor Recreation Participants: Reservoir Boating

Mancos State Park Visitation 2019-2021




Mancos State Park Annual Visits

Mesa Verde National Park Annual Visitation 2002-2022



- Visitation not recovered to level before 2018 fire season


Mesa Verde National Park Seasonality

Hovenweep National Monument Annual Visitation 2013-2022





Montezuma County Annual Lodgers Tax Collections



- Despite Covid, collections grew 11% from 2019 to 2020


City of Cortez Annual Lodgers Tax Collections

City of Cortez Lodgers Tax Collections by Month 2013-2022




Percent of Cortez Lodging Tax Collections 2013-2022


Annual Hospital District Annual Sales Tax Collections 2017-2022

- Retail sales seasonality is not entirely due to tourism



OHVs in Colorado




- OHV grant funding appropriations are an indicator of # of registered OHVs


