Methodology

Three-hundred and seventy-eight (378) intercept surveys were collected in person from mid-June through mid-September 2023 at trailheads, along Forest Service roads, in campgrounds, lakeside and at outdoor recreation facilities and heritage sites throughout Montezuma County.

The intercept survey began with observations about activities/modes, party size and other visible attributes. The survey was designed to quantify the proportion of visitor use compared to local use, understand trip characteristics among visitors and track visitor spending patterns.

Some of the questions differed depending on whether trail users were residents of Montezuma County or visitors from outside of the county. County residents were asked if outdoor recreation affected their decision to move to Montezuma County or stay in the county. Visitors were asked a series of questions about the characteristics of their trip and their trip-related spending.








Overnight Visitors: where staying

What type of overnight accommodations are you using?





Overnight Visitors Spending by Category




Day Visitors: spending by category




Residents: length of residency
