**A Resolution in support of Montezuma County's grant request to the Colorado State Recreational Trails Grant Program, for the construction of the Paths to Mesa Verde Trail Project Phase 1 Segments C & D.**

**WHEREAS** Montezuma County supports the Colorado State Recreational Trails Program grant application for The Paths to Mesa Verde Construction Phase 1. And if the grant is awarded, Montezuma County supports the completion of the project.

**WHEREAS** Montezuma County has requested **\$250,000.00** from the Colorado State Recreational Trails Program to complete the construction of Phase 1 of the Paths to Mesa Verde Trail Project, from the Town of Mancos to the Mesa Verde Entrance.

NOW, THEREFORE, BE IT HEREBY RESOLVED BY THE MONTEZUMA COUNTY BOARD OF COUNTY COMMISSIONERS THAT:



Section 3: If the grant is awarded, the Montezuma County Board of County Commissioners acknowledges that the objectives of this grant can be completed within 25 years from receiving the grant.


