- * Cable Plowing of Gravel Roads along or through a traveled section BY FOREMAN APPROVAL ONLY
- * All applicants are responsible for the clean-up of the county right of way
- * No company or person shall dig in, or disturb the county right of way without complying with all the above
- * In an Emergency situation these regulations shall be complied with and this form submitted the next working day.
- * Permit Holders must contact property owners where ROW is not fenced

COMPLIANCE WITH LAW: Applicant shall at all time comply with all rules and regulations of the State of Colorado and Montezuma County including Land Use Regulations in connection with construction, installation, placing or use authorized hereunder.



Permit Application Fees for Underground Installations

Road Breach / Location	Asphalt Roads	\$12.50 sf
	Gravel Roads	\$500.00 ea
Road Bore / Location	Asphalt Roads	\$50.00 ea
	Gravel Roads	\$50.00 ea

High Impact *(all work performed from between ditch bottoms)*

Cable Plowing or Trenching / Linear Foot	\$.30 per LF
Disturbed Area / Square Foot	\$5.00 per sf

Low Impact *(all work performed from bottom of ditch to fence)*

Per Location	\$50.00 ea
Linear	(100 feet or more) \$250.00 per mile or \$.05 per LF

Applications will be approved by the Road Superintendent before any excavation. Results for failure to comply with application procedures will be the normal fee multiplied by three.

In case of an emergency the company or person shall deal with the emergency and comply with the application procedure the next working day.
